This year marked a major milestone for The Settlement Home's beloved tradition: the 50th Annual Garage & Estate Sale—Austin's most unique fundraiser supporting one of the city's oldest and most impactful nonprofits.

Founded in 1916 by 12 determined Austin women, The Settlement Home for Children began as a simple day nursery and grew over the decades to meet the evolving needs of Texas foster care. What hasn't changed is the organization's commitment to providing safety, support and stability for children who need it most.

Today, The Settlement Club has expanded to more than 450 women from across the Austin area. Their very first Garage Sale in 1976 set the tone for what would become a signature community event. With 4,200 eager shoppers, that inaugural sale raised an impressive \$36,129 for the Home. Fast forward to this year: the 50th Annual Garage & Estate Sale soared to new heights, grossing more than \$1.8 million—a testament to the passion of the volunteers and the generosity of the Austin community.



For months leading up to the Sale, Club members roll up their sleeves to collect, sort, process, price, and sell thousands of donated treasures. Items range from fine crystal and china to furniture, sports gear, linens, kitchen gadgets, vintage finds, clothing, holiday décor, fine art and countless other surprises. All of it comes together at the Palmer Events Center on the first full weekend of November, transforming the space into a shopper's dreamland.

The festivities begin with the Preview Party, where sponsors and ticket holders enjoy first pick of the goods over dinner and drinks. The Sale then runs Friday through Sunday, building up to the legendary Box Sale, where shoppers purchase an empty box and fill it with as much as they can carry—always a crowd favorite. As part of the Home's commitment to serving the entire community, through their Giving for Living Program, gift certificates are provided to individuals in need so they can select items at no cost.

Mark your calendars now: next year's Sale returns to the Palmer Events Center, November 6–8, 2026. You won't want to miss it!



ABOUT OUR ORGANIZATION



Located in Austin on a 10-acre campus, The Settlement Home is a licensed nonprofit that provides 24-hour care to help children in foster care access the support they need to build and preserve a stable sense of well-being.

Each of The Home's programs builds a foundation for children as they access healing for a hopeful future. The skills they learn and the self-belief they build continue to develop well beyond their time in our care. As adults, they have a higher chance of maintaining steady employment and stable housing, as well as lower chances of incarceration or experiencing homelessness. As parents, they have the ability to build and sustain healthy relationships with their children. All of the children we serve can break the cycle of abuse, and we are dedicated to supporting them as they realize the depth of their potential.

O U R **PROGRAMS**

Residential Treatment Center (RTC)

Our Residential Treatment Center provides care for girls and young women ages 12-18 in a highly structured environment with 24-hour therapeutic support. While many children in foster care are in the state's custody for basic needs, all residents at The Settlement Home for Children come to us with urgent, critical needs. Our RTC is a safe and nurturing environment that enables our residents to begin trusting the healing process.

Group Home Program (GHP)

Our Group Home Program provides care for girls and young women ages 12-18 in a home-like setting with 24hour therapeutic support. The goal of the GHP is to create a family-like environment while giving our residents the opportunity to practice independent living skills that help them prepare for adulthood. Residents go grocery shopping together, cook at home and have independent recreation time.

Supervised Independent Living (SIL)

Our Supervised Independent Living provides 11 efficiency apartments for young women 18 and older who are not quite prepared to live on their own and therefore choose to remain in the custody of Child Protective Services. Residents in our SIL live in apartments on our campus and receive case management and therapy. These young women continue to build life skills like financial literacy and job preparedness.



Foster & Adoption Program (FAP)

Our Foster & Adoption Program works with Child Protective Services to provide either a temporary or permanent home for boys and girls of all ages who can no longer remain in their current living situation. To best support our children and families, our FAP trains foster and adoptive families in trauma-informed care, supports them through the foster and adoption process and provides post-adoptive services such as therapy and resource referrals.

Post Adoption Services

Our Post Adoption Services provides support to families after adoption including family therapy, parent coaching and more.

University of Texas Charter School

Our on-campus University of Texas Charter School serves students from sixth through 12th grades and provides special education services, credit recovery and tutoring.


